Subject: FLASH FLOOD WARNING

Dear Sir,

I am directed to enclose herewith the Alert no. A-01/2026 dated 20th January, 2026 received from Chief Meteorologist FFD, Lahore on the subject noted above wherein it is intimated that **a strong westerly wave is likely to affect the upper parts of the country from the evening of 21st to 24th January, 2026 consequently flows in River Kabul along with its tributaries may rise during 22nd to 23rd of January, 2026.**

Furthermore, on account of expected **Moderate to Isolated Heavy rainfall coupled with Snowfall** over the upper parts of the Khyber Pakhtunkhwa (Swat, Chitral (Upper & Lower), Buner, Shangla, Dir (Upper & Lower), Malakand, Bajaur, Abbottabad, Mansehra, Battagram, Torghar, Haripur, Kohistan (Upper & Lower), Kolai Pallas, Mardan & Swabi), **the risk of flash flooding cannot be ruled out.**

It is therefore requested to kindly take all precautionary measures to avoid any loss of life, damages to infrastructure/ crops and animals. Furthermore, all concerned authorities may be requested to take the following safety measures:

- a) **Identification of vulnerable points / at-risk communities and devise mitigation and safety measures.**
- b) **Maintain enhanced alert level / monitoring of developing situation to reduce reaction / response times.**
- c) **Rescue 1122 & Civil Defence to remain alert and ensure availability of personnel and equipment during the forecast period, especially in at-risk areas.**
- d) **People living along the banks of River Kabul and its associated Nullahs to be sensitized about expected increase of water flows.**
- e) **Timely evacuation of at-risk population from low-lying / flood prone areas as per Evacuation Plans and availability of shelter, food and medicines in those shelter camps.**
- f) **Locals / farmers / cattle herders be forewarned to shift cattle away from low lying areas adjacent to River Kabul and its associated Nullahs.**
- g) **Restrict vehicle movement in low lying / at-risk areas, close to River Kabul and its associated water channels / nullahs.**
- h) **Provision of relief / medical supplies to affectees in timely manner.**
- i) **Coordinate with concerned departments for clearance of roads in case of any blockage / obstruction, waterlogging and pre-placing of necessary emergency equipment at vulnerable / appropriate locations.**
- j) **In case of any occurrence, updates may kindly be shared with PEOC, PDMA on 6th hours basis**
- k) **PEOC, PDMA is active round the clock via helpline 1700 for any guidance and help**


FLASH FLOOD WARNING

A strong westerly wave is likely to affect the upper parts of the country from the evening of 21st to 24th January-2026 consequently flows in River Kabul along with its associated tributaries may rise during 22nd to 23rd of January-2025.

On account of expected Moderate to Isolated Heavy rainfall coupled with Snowfall over the Upper parts of Khyber Pakhtunkhwa (Swat, Chitral, Buner, Shangla, Lower & Upper Dir, Malakand, Bajur, Chitral, Mardan, Swabi, Abbottabad, Mansehra, Battagram, Torghar, Haripur, Kolai-Palas, Kohistan,) and Kashmir, the risk of flash flooding cannot be ruled out.

Concerned authorities are advised to remain vigilant and take necessary precautionary measures. PDMA/DDMA & Local administration and emergency services should ensure readiness to respond to any untoward situation. Residents of vulnerable and low-lying areas, particularly near streams and nullahs, are advised to exercise caution and avoid unnecessary movement during the forecast period.
