Subject: MORE RAIN - WIND/ THUNDERSHOWER PREDICTED IN UPPER PARTS OF THE COUNTRY

Dear Sir,

I am directed to refer to the subject noted above and to state that Pakistan Meteorological Department, Islamabad has predicted that monsoon currents are penetrating upper parts of the country. A westerly wave is also affecting upper parts and likely to strengthen on **04th & 05th September**.

Under the influence of this weather system:

- **Rain-wind/ thundershower (with scattered heavy falls at times very heavy)** is expected in Chitral (Upper & Lower), Dir (Upper & Lower), Swat, Bar-Swat, Shangla, Buner, Malakand, Bajaur, Kohistan (Upper & Lower), Kolai-Pallas, Battagram, Torghar, Mansehra, Abbottabad, Haripur, Mardan, Swabi, Khyber, Mohmand, Peshawar, Charsadda, Nowshera, Kohat, Kurram, Hangu, Orakzai, Karak, Bannu, Lakki Marwat, DI Khan, Tank, North Waziristan and South Waziristan (Upper & Lower) from **03rd (evening/night) to 05th September** with occasional gaps.

Possible Impacts:

- **Landslides** may occur in vulnerable areas in Chitral (Upper & Lower), Dir (Upper & Lower), Swat, Bar-Swat, Shangla, Battagram, Mansehra, Kohistan (Upper & Lower) & Abbottabad during the forecast period.
- Heavy to very heavy rain may cause **Flash flooding** in local streams/ nullahs in Dir (Upper & Lower), Chitral (Upper & Lower), Swat, Bar-Swat, Kohistan (Upper & Lower), Shangla, Battagram, Buner, Malakand, Mansehra & Abbottabad during the forecast period.
- Heavy to very heavy rains may cause **Urban flooding** in low lying areas of Peshawar, Mardan & Swabi on 04th & 05th September.

It is therefore requested to kindly take all necessary precautionary measures to avoid/minimize loss of human lives, livestock, and damage to infrastructure and crops. Furthermore, all concerned authorities are requested to undertake the following safety measures:

- a) All Districts Administration to take proactive measures in their respective districts, especially in vulnerable houses and communities to ensure timely action.
- b) Local administrations to assess and plan deployment of additional resources and exercise control over traffic leading to and in vicinity of vulnerable/ choke points/ tourist spots/ attractions and securing (by physical means and keeping people away) from loose structure such as buildings under constructions, advertisement hoardings, electric poles, solar panels etc. to prevent losses/damages and save precious lives.
- c) Main/ linked roads shall be kept clear and open.
- d) Uninterrupted water supply shall be ensured.
- e) Ensure sufficient quantity of daily food and other commodities.
- f) Petrol pumps shall be kept functional with sufficient fuel availability for public;
- g) Advice concerned with keeping monitoring on Rivers, Streams, Local/ Barsati Nullahs.
- h) Tourists are advised to remain extra cautious and avoid unnecessary travel during the forecast period.
- i) Ensure timely mobilization of Rescue 1122 teams where response is required to passengers or other local communities during travelling.
- j) Ensure that drainage systems are clear of debris and obstacles to facilitate the efficient flow of water and minimize the risk of urban flooding.
- k) Coordinates with relevant municipal administrations to ensure mitigation &



preparedness measures for landslides/ urban flooding and to secure or remove billboards/ hoardings because of wind/ thunderstorm.

- l) Farmers to be advised to take all necessary mitigative and precautionary measures to safeguard their crops, i.e., timely harvesting, safe storage, or any other precaution from adverse effects of wind & thunderstorm.
- m) Cattle/ sheep herders to be advised to undertake necessary mitigative and precautionary measures to protect their livestock, i.e., safe sheltering or any other precaution from adverse effects of wind/ thunderstorm.
- n) Travelers on Provincial & National Highways in at-risk / affected areas be forewarned of adverse conditions and detoured to safe waiting areas under the guidance of respective local authorities, national highway & motorway police, LEAs, etc.
- o) The general public is advised to seek shelter in safe areas such as sturdy buildings or underground structures during wind & thunderstorm, and avoid objects that pose a risk of failing or being struck by lightning.
- p) Ensure availability of emergency services personnel and equipment in areas at high risk of urban flooding, flash flooding and landslides.
- q) Ensure immediate stocking of basic commodities, including paramedics & medicine, especially in regions that are likely to get cut off during landslides.
- r) Ensure widespread circulation of alerts and advisories, especially in local languages, to raise awareness and sensitize travelers/tourists and local communities in at-risk/ vulnerable areas.
- s) Travelers/tourists are advised to: -
 - Plan travels to picnic and tourist spots, considering weather and traffic conditions.
 - Properly dispose of garbage at designated areas to prevent clogging of drainage systems.
 - Avoid overcrowding picnic and tourist spots and ensure personal safety.
 - Keep children away from rivers/ nullahs/ pot holes/ drainage lines to avoid accidents.
 - Wear weather appropriate clothing.
 - Choose hotels and guest houses located on higher ground and away from rivers, lakes, or nullahs in monsoon/ flooding season.
 - Ask hotel staff about emergency exits, local hazards and evacuation procedures in case of flooding.
 - Carry sufficient drinking water, food supplies, medicines, and power banks, as prolonged road blockage and delays are possible due to landslides.
 - Maintain safe distance (minimum 20 feet) from rivers, streams, and nullahs, as sudden water rise may occur.
 - Avoid swimming in the rivers/ nullahs and any water body during flooding season.
 - Avoid walking or driving through flooded areas just 6 inches of moving water can knock you off your feet.
 - Avoid trekking, hiking, or camping during heavy rains the risk of landslides, slippery trails, and flash floods increases.
 - Avoid self-driving in unfamiliar or hilly areas during rain opt for local drivers who know the terrain.
 - Do not attempt to cross bridges or roads submerged in water they may be damaged or unstable.
 - Cooperate with locals and district authorities, rescue agencies during emergencies or weather disruptions.
- t) General Public are advised to: -
 - Do not risk cross any drain or road overtopping with water flow. Wait for flows to normalize and priorities/ ensure safety.
 - Do not risk enter a ponded under-construction road.
 - Do not take/ allow children close to ponds/ stagnant water, water drainage lines or any other place where pot holes are present.
 - Do not handle/ repair any electrical equipment, especially with exposed lines to preclude risk of electrocution during rainfall/ thunderstorms and water pondage.



- u) Ensure a proactive approach by diverting traffic, providing alternate routes, imposing movement/travel restrictions, to avert any situation of road closure with stranded travelers in light of forecasted weather.
- v) Ensure round-the-clock monitoring of the situation through Emergency Operations Centers (EOCs).
