**WHEREAS,** the Secretary Agriculture, Livestock and Cooperatives Department, Khyber Pakhtunkhwa has shared a situation report, and brief regarding the presence of Locusts infestation in Southern Districts of Khyber Pakhtunkhwa, and the apprehension of their spread due to rising temperature vide letter No. SOAII(AD)1(14)/2019/Vol-III dated 29.01.2020;

**AND WHEREAS,** Secretary Agriculture, Livestock and Cooperatives Department, Khyber Pakhtunkhwa has requested for declaration of emergency in respect of the districts mentioned below vide the above referred letter;

**AND WHEREAS**, the province of Khyber Pakhtunkhwa is already wheat deficient, and its Southern Districts being critical to wheat production;

**AND WHEREAS,** immediate measures need to be taken for the protection of the crops and agriculture areas in Khyber Pakhtunkhwa;

**NOW THEREFORE,** in exercise of powers conferred under section 16(A)(1) of National Disaster Management (Khyber Pakhtunkhwa), Act [as amended from time to time], I as, Secretary Relief, Rehabilitation and Settlement Department, Khyber Pakhtunkhwa, declare an emergency to the following extent in districts of South Waziristan, Tank, Dera Ismail Khan, Lakki Marwat, Bannu, North Waziristan, Karak, Kohat, and Hangu:

- (i) Applicability of this emergency shall be to the extent of proactive and reactive measures of Agriculture, Livestock and Cooperatives Department, Khyber Pakhtunkhwa for the Locusts control including protection through spray and other containment measures;
- (ii) Establishment of District Management Committees as under in the above mentioned districts for effective coordination:-

(iii) Establishment of Emergency Response Cell at the level of Agriculture, Livestock and Cooperatives Department main office, and also at the level of office of District Director Agriculture in each district; and,

(iv) All departments shall provide such assistance to Agriculture, Livestock and Cooperatives Department, Khyber Pakhtunkhwa in the matter up to the extent of relevancy of functions of the departments.
