**NOTIFICATION:**

**No. SO (Admn) RR&SD/2-49/2020:** In continuation to para-2 of this department notification of even number dated 27.03.2020, regarding the exemptions to the closure, the Provincial Government is pleased to **exempt the retail operators for disbursement of funds to Ehsaas Kafalat beneficiaries and beneficiaries of Benazir Income Support Programme (BISP)** subject to the observance of directives issued by Bank Alfalah, being assistance provider and also to the adaptation of following standards:

- i. Designated spots or points may be marked for queues with minimum three feet distance between such points for ensuring social distancing between beneficiaries;
- ii. Hand sanitizers may be installed and or provided before any transaction or contact between the retailer and the beneficiaries;
- iii. No traditional modes of greetings be observed: hand shake & hugs;
- iv. Within closed premises of such service providers not more than 5 people shall be allowed; and,
- v. The infrastructure, premises and gadgets etc of such service providers may be sanitized and disinfected every day.

Subject: **REGULATED DELIVERY OF FOOD FOR PETS – SHOPS, OUTLETS AND HOME DELIVERY**

Dear Sir,

Regulated exemptions have been granted to essential outlets which provide food for birds and animals including seeds and fodder and animal feed mills. However, there is a need to also cater to pets maintained by people, but under strict regulations.

2. The regulation of the above has been decided to be left to the parameters set by District Administrations, BUT based on the following general principals, amongst others:

- (i) Preferably the pets animals etc feed delivery should be as home delivery to ensure physical distancing, and during that delivery following protocol must be ensured
  - a) Packed food and medicines of pets brought into the house from outside through delivery shall be first washed, sanitized, cleaned, and afterwards used. Such things shall be brought to one segregated and specified point with great care in the house and afterwards that point may be sanitized properly.
  - b) Packaging of food and medicines of pets shall be sanitized and washed, as the case may be, at a segregated and specified point in the house.
  - c) All vehicles transporting food and medicines of pets shall be washed and disinfected before the start of work.
  - d) All the individuals operating such vehicles shall keep hand hygiene: washing of hands with soap for 20 seconds after every hour.
  - e) All the individuals involved in such deliveries shall follow hand hygiene timeline as above alongwith use of protective gear which shall include gauze cap, surgical masks and gloves.
  - f) All such deliveries of food and medicines shall invariably follow the major principles of social distancing while handing and taking of the same: 3 feet

distance; gloves on hands; face masks; no hand shake and hug; and washing of hands by the recipient and the deliverer afterwards.

- g) The use of polythene bags may be discouraged, and wherever such use is inevitable, it may be brought from outside to a specific point in such facility
- h) All other conditions as laid down in various notifications and instructions issued by Relief Department shall apply to the above exemption.

(ii) In case of requiring an outlet perforce, its timings should be announced clearly to anyone desiring to acquire food for their pets (it is presumed that such people will be limited and other protocols of assembly for controlling the spread of COVID-19 are followed) so that they could collect food from there – preferably store it up at their homes for a longer period. Such announcements can be on social media too
