NOTIFICATION

No.SO(Admn)RR&SD/2-49/2022: WHEREAS As per decision of the Ministry of Interior (Moi) taken in a meeting of 7th February, 2023; the Government of Khyber Pakhtunkhwa Home & TAs Department notified Steering Committees at Provincial level with regards to repatriation of Illegal Foreigners on 15th February, 2023; The Provincial Steering Committee assigned a task to PDMA regarding carrying out proper estimation of budgetary requirements for a transit / staging point in District, Khyber, Peshawar and Nowshera.

AND WHEREAS The Provincial Cabinet in its Special meeting held on 3rd November, 2023, also directed to established transit / Staging points in the above districts on immediate grounds and approved the declaration of emergency for carrying out the establishment & operational activities of these points;

AND WHEREAS Section 16(A)(1) of the National Disaster Management (Khyber Pakhtunkhwa) Act 2010, as amended from time to time, states that whenever the Province or any part thereof is affected or threatened by disaster which warrants action under this Act, the Secretary to Government of Khyber Pakhtunkhwa Relief, Rehabilitation & Settlement Department may, by notification, declare the whole or any part of the Province, as the case may be, as an affected area;

NOW THEREFORE, in exercise of powers conferred under Section 16(A)(1) of National Disaster Management (KP) Act 2010 and upon the approval of Provincial Government, I Secretary, Relief, Rehabilitation & Settlement Department hereby declare "**Emergency**" in District Khyber, Peshawar and Nowshera **w.e.f: 1st November, 2023** to the extent of carrying out establishment and operational activities in the transit / staging points of the said districts;

AND NOW FURTHER THEREFORE, The Director General PDMA, the Deputy Commissioners Khyber, Peshawar and Nowshera is authorized to mobilize all resources and engage necessary Machinery & other equipment's to establish and to operate these transit / staging points for repatriation of illegal foreigners. All the expenditure on the above shall be a fit charge on the specific funds released by Finance Department to PDMA or further released by PDMA to Deputy Commissioners from these funds under Relief Account for prudent & judicious expenditure. Proper accounts / inventory register be maintained by the PDMA/ Deputy Commissioner and all expenditure, issuance of articles etc must be accounted for as per formal government procedure, and the account on above count may be provided to the Provincial Disaster Management Authority and share the same with the Chairman of the Departmental Committee for further examination / scrutiny.


