



## TENDER NOTICE

### FOR PROCUREMENT OF RELIEF GOODS UNDER FRAMEWORK AGREEMENT

1. Director General, Provincial Disaster Management Authority (PDMA), GoKP, Peshawar invites sealed bids under National Competitive Bidding from eligible registered firms/manufacturers fulfilling the required criteria mentioned in Standard Bidding Document for procurement of the Relief Items as per Followings.

2. Successful bidders shall submit performance guarantee @ 10% (in shape of bank guarantee) of the total purchase order after signing framework agreement.

3. The nature of contract shall be framework agreement as per rules 31-A of KPPRA Rules 2014 ibid wherein the agreed rates per item shall be finalized and the bidders shall provide the same as and when needed by PDMA authorities over a period of one year (extendable to another year). The total quantities of relief items mentioned in the SBD's for the contract period are tentative and can be increased or decreased as per requirement and any emergency situation in the province.

4. Bidding documents, detailed description and quantities of items, can be obtained from the office of the Assistant Director Procurement PDMA Sector B-2, Phase v, Hayatabad Peshawar during office hours till **26.10.2022** against the non-refundable cash payment of Pak Rupees Three Thousands (Rs. 3000/-PKR).

5. The bids shall reach to the Office of the **Assistant Director (Procurement) PDMA**, through registered Dak or Courier Services and by hand submission on or before **27.10.2022** at **11:00 AM**. The bids shall be opened on the same day by the Procurement Committee in the presence of Representatives of the bidders who chose to attend at **11:30 AM** in the Conference Room of PDMA

7. Bids received late will be treated as non-responsive.

8. Bids shall be quoted in Pak Rupees inclusive of all government taxes where applicable.

9. There shall be a pre-bid meeting with the interested bidders on **17.10.2022 at 2:00 PM** in the conference Room PDMA Sector B-2, Phase v, Hayatabad, Peshawar.

10. All participating bidder in the tender shall submit 02 No's of samples of each items for evaluation and laboratory testing to PDMA warehouse located at Chirat Road Jaloza District Nowshera on or before **27.10.2022 at 11:00 AM sharp**. Bids without samples will be treated as non-responsive

10. Bidders are required to offer most competitive lowest rate of their items inclusive of all the taxes, as negotiations on quoted rates are not allowed under the rules.
